<p>There are areas within Thornbury park that are being used for criminal activity that has been an issue for many years. Carillon have recently coppiced the stack of trees that ran adjacent to the muga as this spot was identified as a hiding spot for street drinkers and drug use. These works have already produced a reduction in the amount of drugs paraphernalia found on site so are considered a success.</p> <p>This site is also used by rough sleepers and despite a task force being set up at the start of the year we can confirm that there are two new encampments within the woodland which are hidden from view by the trees and coppiced area.</p> <p>These proposals seek to bring closure on the opportunity for unseen rough sleeping which will deter the activity from occurring on site.</p>

This will improve line of site. • Removal of all shrubs and hedges behind the public bench • Flail and brush cut all remaining vegetation • Severance of ivy on all trees • Chemical application to deter the growth of unwanted stumps along the desire lines to improve walkways through woodland <p>Section 2 + 3</p> <ul style="list-style-type: none"> • Selective felling and stump removal of several coppice stacks • Selective Felling of small trees/weak trees within the woodland • Flail and brush cut all remaining vegetation • Severance of ivy from trees • Chemical application to deter the growth of unwanted stumps along the desire lines to improve walkways through woodland <p>Other</p> <ul style="list-style-type: none"> • Wildlife survey by the countryside team • Stump grinder consumables <p>Note: All measurements are taken from the GIS survey and should be treated as estimates. It is up to the contractor to make sure these are correct and price accordingly at quote stage.</p>

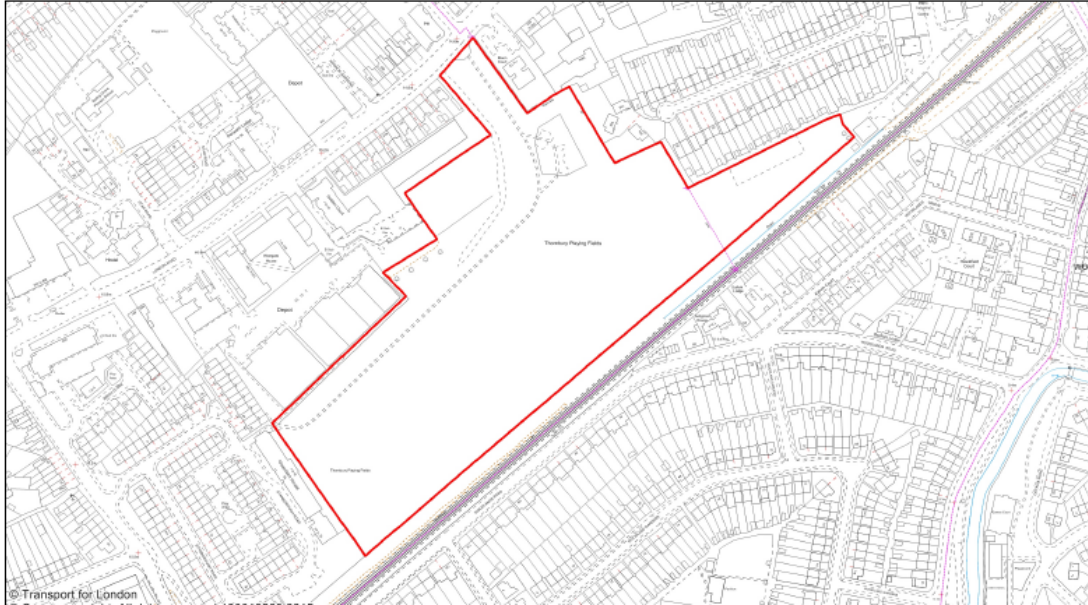
